Thank you for the opportunity to nominate persons to fill the Alabama Obligatory seat on the Gulf of Mexico Fisheries Management Council that is currently held by Susan Boggs of Alabama. The work of the Gulf Council is very important to the State of Alabama. Alabama has a very large charter fleet, a robust recreational fishery, a small but critical commercial fleet, and is the leader in seafood processing on the Gulf Coast. It is imperative to the economic and conservation interests of our state that Alabama be fairly represented on the Gulf of Mexico Fisheries Management Council.

In accordance with the Magnuson-Stevens Act and 50 CFR 600.215, the State of Alabama would like to nominate the following three individuals for the Obligatory seat that is to be filled in 2024: Joseph G. Dobbs (recreational), Troy Frady (charter), Matthew Womble (recreational/other). I recommend that Matthew Womble be appointed to this Alabama Obligatory seat.

Matthew R. Womble is the Executive Director of the Alabama Water Institute at the University of Alabama. He is the former Senior Director of Ocean Programs at Saildrone Inc. Prior to his work in the private sector, Mr. Wonble was on the Professional Staff at the United States Senate Committee on Appropriations. He was also Science Fellow and Policy Analyst at the National Oceanic and Atmospheric Administration (NOAA). Mr. Womble has been a recreational fisherman for various species for more than 25 years. His affinity for the Gulf of Mexico has transcended into his professional realm. He has a nuanced understanding of the complexities inherent in managing and sustaining fisheries. His network within the fishing community, NOAA, and the United States Congress has provided valuable insights into the diverse perspectives and interests that underpin complex Gulf of Mexico fisheries. He professes a steadfast commitment to ensuring that the voices of all anglers, irrespective of their sector, are heard and considered in the decision-making process. The pillars of his root philosophy are

balanced, science-based, and transparent. I feel that Mr. Womble will bring a unique perspective to the work of the Gulf Council.

Joseph G. Dobbs, Jr., is the former owner of Landscape Workshop, LLC. Mr. Dobbs is Chairman of the Alabama Conservation Advisory Board and was a founding member of the Gulf Coast Conservation Association. He is a current member of the Coastal Conservation Association-Birmingham, Alabama Chapter. Mr. Dobbs is an avid fisherman for inshore, offshore, and reef fish species. He spends much of his time in Coastal Alabama and has been active in the fisheries issues in our state. Mr. Dobbs has a vast knowledge of coastal fisheries and is actively involved with persons in Alabama, and other states as well, concerning coastal fisheries issues. He founded Landscape Workshop in 1986. Landscape Workshop now has four locations in Alabama and has over 300 employees. Dobbs is a board member of the Birmingham Association of Landscape Professionals, the Birmingham Construction Authority, Auburn School of Horticulture, and American Subcontractors Association - Alabama Chapter, and is on the executive committee of Magic Moments, benefiting children with life-altering and life-threatening diseases. Mr. Dobbs has relationships with commercial, recreational, and charter fishermen along the Gulf Coast. He would be very open-minded and wants to work cooperatively with all sectors, the other Gulf States, and the federal government to use best management practices to ensure viability of our marine resources.

Troy Frady is a full-time federal for-hire charter fisherman on the vessel *Distraction* in Orange Beach, Alabama. He considers himself an educator, in addition to being a boat captain. He provides an experience well beyond just fishing during his trips by discussing management, conservation efforts, and history of fishing. Mr. Frady has been a transportation logistics manager, bank officer, and a commercial pilot. He is also a veteran of the United States Navy. There are very few Gulf Council meetings that Troy does not attend to provide comment on current fishery management plans. He has been a member of several Council panels and committees and is very open-minded and involved in all aspects of the Council process.

The nomination process is very important to the State of Alabama. The Alabama Department of Conservation and Natural Resources (ADCNR) has met with a variety of groups before selecting the above nominated individuals. The following organizations were consulted in the process: the Organized Seafood Association of Alabama, Coastal Conservation Association, Alabama Coastal Fisherman's Association, Orange Beach Fishing Association, Alabama Seafood Marketing Commission, Alabama-Mississippi Sea Grant, University of South Alabama Department of Marine Sciences, University of Alabama, Dauphin Island Sea Lab, Gulf of Mexico Shareholders Alliance, Coastal Alabama legislators and mayors, several charter

fishermen, recreational fishermen, marina operators, and other concerned and knowledgeable individuals.

ADCNR actively worked to recruit and consider qualified women, people of color, and individuals representative of historically underserved communities. ADCNR will continue to work with organizations in Alabama to diversify the nominations for future seats on the Council and in nominations for advisory panels. I sincerely hope you will act on my recommendation to appoint Matthew Womble to this critically important Obligatory seat on the Gulf of Mexico Fisheries Management Council.

After careful consideration of each applicant, it is my pleasure to recommend the below individuals for this obligatory seat. These individuals are well qualified and would make an excellent appointment for the Gulf of Mexico Fishery Management Council. I am providing

these individuals in order of preference and ask that you give strong consideration to the preferred nominee. This seat has historically been a commercial seat for Florida. We have provided three strong commercial candidates.

I am recommending Juan "John" Sanchez as the preferred choice for appointment to the Florida obligatory seat on the Gulf Council. Mr. Sanchez is a seasoned Council member as he has previously served on the Gulf of Mexico Fishery Management Council from 2012 – 2021 and served on the South Atlantic Council from 1997 – 2000. While Mr. Sanchez currently works as a General Manager for Sunshine Gasoline Distributors, Inc in the commercial fuels division, his past experience supporting Monroe County commercial fishermen (MCCF) as the Executive Director of the Monroe County Commercial Fishermen's Association and his avid recreational fishing background will serve him well in advocating for sustainably managed fisheries resources in the Gulf of Mexico. Mr. Sanchez has vast experience in working with the commercial, charter for-hire, and private recreational fishing industry through his past work on the Council, MCCF advocacy, and his experience as the chair of the Key West Challenge Fishing tournament. He also has knowledge of the Florida Keys National Marine Sanctuary and its importance to the nation's economy. Mr. Sanchez has also testified before Congress on important fisheries issues in the Florida Keys. This vast diversity of experience and fluency in both English and Spanish make him the perfect candidate for this Florida Council seat.

My second recommendation is <u>Casey Streeter</u>. Mr. Streeter's commercial fishing business, vessels, and seafood wholesale and retail operation in Matlacha, Florida was recently hit hard by Hurricane Ian. He fought hard for the recovery of his local fishing community that was devastated by this storm. Mr. Streeter has knowledge of the federal fishery management process as he currently serves as the Vice-Chairman of Gulf Council's Ecosystem Technical committee. He is also founder of the Florida Commercial Watermen's Conservation, a 501C3 that had fishermen working with NOAA on monitoring the waters off Southwest Florida following numerous red tide events that began in 2015. Mr. Streeter is an intense advocate for Gulf fisheries resources and fishermen and has over a decade of knowledge in the federal fisheries management process.

My third recommendation is <u>Austin Abrams</u>. Mr. Abrams believes in protecting all marine life in the Gulf of Mexico for current and future generations. He is a third-generation seafood house owner and operator at Greg Abrams Seafood. Mr. Abrams has strong connections with the commercial fishing industry and other seafood houses. As a Council member he will strive to protect the

Gulf fishery resources and the commercial fishing industry. Mr. Abrams has attended the Marine Resource Education Program to learn about the federal fisheries management process.

In summary, my recommendation is as follows:

I appreciate your consideration of my nominees for this important Florida seat and look forward to seeing citizens of Florida continue their service on the Councils in ways that will help ensure wise and sustainable use of our saltwater fishery resources in the Gulf of Mexico. Thank you for the opportunity to submit nominations for the at-large seat on the Gulf of Mexico Fishery Management Council (Gulf Council) currently held by Dale Diaz. In accordance with the Magnuson-Stevens Act and 50 CFR § 600.215, the State of Mississippi nominates the following three individuals to the at-large seat to be filled after August 10, 2024: Jason Osborne, Michael Brainard and John Marquez. My top recommendation to represent Mississippi as a Gulf Council member for the at-large seat is **Jason Osborne**.

After reviewing the education, experience and background of each of the nominated individuals and consulting with appropriate representatives of the environmental community, the recreational, the commercial and the for-hire charter segments of the fisheries, I feel each of these individuals meet the requirements of the Magnuson-Stevens Act. More importantly, their qualifications identify them not only as efficient stewards of fisheries resources but also as individuals prepared to meet the task of attaining the desired management goals of the Regional Fisheries Management Councils.

My top nominee Jason Osborne is an appointed member of the Mississippi Advisory Commission on Marine Resources, where he is involved in the rules and regulations necessary for the protection, conservation or propagation of both the commercial and recreational fisheries in the marine waters of the State of Mississippi. Mr. Osborne previously worked for Alaska Senator Ted Stevens on the 1996 amendments to the Magnuson-Stevens Fishery Conservation and Management Act. He brings more than 30 years of experience working on national and international government affairs, serving in senior roles in Presidential and international administrations providing high-profile legislative advocacy, in addition to serving as a consultant to the Center for Sportfishing Policy in Washington DC. Mr. Osborne also has been directly involved in the fishing industry in the Pacific, most recently working with the Commonwealth of the Northern Mariana Islands representatives of the Western Pacific Fishery Management Council.

Michael Brainard has 33 years of experience in fisheries management in the State of Mississippi working for the Department of Marine Resources as a fisheries biologist, Director of the Shrimp and Crab Bureau, and Deputy Director of the Office of Marine Fisheries. Mr. Brainard has been appointed to a variety of fisheries-related commissions and councils throughout his career including the Gulf Council's Special Shrimp Science and Statistical Committee (SSC).

John Marquez is the Director of Coastal Policy and Program at the Mississippi Wildlife Federation where he oversees coastal policy advocacy with an emphasis on transparent and science-based decision making for coastal restoration projects and sound fisheries policies for both state and federally managed species. He has served on several Gulf Council Advisory Panels including the Reef Fish AP, Data Collection AP, Red Snapper Ad-Hoc AP and the SEDAR 74 Stock Assessment Panel.
