I respectfully request that you appoint Mr. John Moller or Mr. John Jensen.

Mr. John Moller, an Aleut from Unalaska with a lifelong connection to subsistence and commercial fishing, has served on the Qawalangin Tribe of Unalaska Council and the Ounalashka Corporation Board. With four decades in commercial fishing, he is the owner and operator of a vessel operating in Southeast Alaska, with experience from Amchitka to Nome. He has managed both a halibut charter vessel and fish processing plants in Adak and Atka and led a

Western Alaska Community Development Quota Organization. His six years on the NPFMC Advisory Panel and involvement in its Crab and CDQ Committees bring a vital, well-rounded perspective to the Council's decision-making.

Mr. John Jensen, a commercial fisherman with over fifty years of experience in Alaska's diverse fishing regions, has consistently been involved in the management and regulatory processes of the industry. A longtime Petersburg, Alaska resident, he has shown a deep understanding of the State's reliance on fishery resources through his commercial endeavors and a self-guided recreational skiff rental business. His contributions to the Alaska Board of Fisheries and the North Pacific Fishery Management Council demonstrate his dedication to sustainable fisheries management. With practical experience ranging from gillnetting to operating larger fish tenders, his broad expertise and commitment to conservation and community represent the principles vital for a member of the NPFMC.

Mr. Samuel Rabung is the Director of Commercial Fisheries for the Alaska Department of Fish and Game. He upholds the Division's mission to manage subsistence, commercial, and personal use fisheries in the interest of the economy and general well-being of the citizens of the State, consistent with the sustained yield principle, and subject to allocations through public regulatory processes. Mr. Ritchie was born and raised in Homer, Alaska, where fishing commercially and recreationally are vital to the local economy and the culture. His upbringing and fisheries involvement have brought him a deep understanding of the value of the varied sectors and fleets that fish and subsist in the North Pacific. He received a Master's Degree in Environmental Science from APU. His studies were focused on fisheries. The education and guidance he had through the development of his thesis helped him gain new perspectives on fisheries science, management, and their interactions. Mr. Ritchie seeks to bring these perspectives to the Council and to help ensure that management is based on sound science and on weighing the interests and wellbeing of all stakeholders.

Mr. Samuel Rabung is the Director of Commercial Fisheries for the Alaska Department of Fish and Game. He upholds the Division's mission to manage subsistence, commercial, and personal use fisheries in the interest of the economy and general well-being of the citizens of the State, consistent with the sustained yield principle, and subject to allocations through public regulatory

Dear Ms. Coit,

Please accept the following nominees, ranked in priority order, for one of the two obligatory Washington State seats to the North Pacific Fishery Management Council (NPFMC). The seat is currently held by Ms. Anne Vanderhoeven of Seattle, whose term expires on August 10, 2024.

Washington State has consulted with a broad range of interested parties in seeking nominations; the consultation list is attached. As requested by our federal partners, efforts were made to nominate individuals with knowledge and experience in the conservation and management of marine resources and other sectors including: women, people of color, tribal members, subsistence users, individuals representative of historically underserved communities. In addition, we have considered the need for experience and perspective related to conservation of fisheries, ecosystems and habitat and respect to environmental protections especially considering the rapidly changing climate.

Additionally, in conjunction with the Washington Department of Fish and Wildlife, we have evaluated each candidate's leadership and experience relative to the Magnuson Stevens Act and Governor's Guidance Document. Lastly, my office conducted initial background reviews, and determined that none of these nominees are federally registered lobbyists. Ms. Goen and Ms. Vanderhoeven should be classified as "Commercial" sector, while Ms. Robbins-Gisclair and Ms. Harvey should be classified in the "Other" sector.

Based on my evaluation of each candidate's qualifications, I am recommending the following individuals in priority order.

### 1. Ms. Becca Robbins-Gisclair:

Ms. Robbins Gisclair is the Senior Director of Arctic Programs for Ocean Conservancy, where she works closely with Alaska Tribes and grassroots organizations to protect a region that is on the frontlines of global climate change. She developed an in-depth understanding of the Bering Sea ecosystem and fisheries through two decades of involvement in the North Pacific Fishery Management Council (NPFMC) process, including six years on the Advisory Panel with four of those in leadership, and as a Board member of the North Pacific Research Board (NPRB). She serves as a domestic advisor for the North Pacific Anadromous Fish Commission and the Bering Sea Fishery Advisory

Body and has worked for several Alaska organizations as a natural resources advisor. She resides on Coast Salish lands in Bellingham, Washington.

### 2. Ms. Jamie Goen:

Ms. Goen is the Executive Director of the Alaska Bering Sea Crabbers, a trade organization representing crab harvesters. She participates regularly in the North Pacific Fishery Management Council process and has worked with four of the eight regional fishery management councils around the country. Ms. Goen has broad experience in fisheries management after working for NOAA Fisheries for 15 years and as part of the leadership team at the International Pacific Halibut Commission. She has hands-on experience working on boats, working with all gear sectors from open access to rationalized fisheries, working for domestic and international fisheries, and conducting oceanographic research around the world that is the foundation of climate science. She resides in Seattle, Washington.

### 3. Ms. Elaine Harvey:

Ms. Harvey is the Watershed Department Managers for the Columbia River Intertribal Fish Commission, a tribal coordinating body comprised of the four Tribes of the Columbia Basin. Her unit oversees many aspects of the Columbia River, water quality, and Coastal Margin Observation Prediction Program. Her prior work experience was in the Yakama Nation Fisheries section of the tribe's Department of Natural Resources, including Environmental Coordinator, Hydro Systems Oversight Coordinator and Forest and Fish Biologist. Ms. Harvey is a member of the Yakama Nation and resides in Goldendale, Washington.

### 4. Ms. Anne Vanderhoeven:

Ms. Vanderhoeven is the Director of Government Affairs for Arctic Storm Management Group, a position she has held since 2017. Arctic Storm is a Seattle company that owns and operates several fishing vessels that participate in groundfish harvests in the Bering Sea, Gulf of Alaska as well as fisheries managed by the Pacific Council. Previously, she worked for several organizations in Alaska that participate in NPFMC fisheries, as a fishery manager and as an observer. Over the last decade, she has served on the Council's Advisory Panel, Fishery Monitoring Advisory Committee and Non-target Species Committee. She serves on numerous Boards, including the Bering Sea Fisheries Research Foundation, Marine Conservation Alliance, Pollock Conservation Cooperative, At-Sea Processors Association, United Catcher Boats and High Seas Catcher Cooperative. Ms. Vanderhoeven resides on Bainbridge Island, Washington.

I am confident our four nominees are well qualified to serve on the NPFMC and will continue the work to support management values that promote resource conservation, habitat protection, and sustainable fisheries. Additionally, I hope the Council will continue to maintain sustainable stocks and encourage consideration of new technologies to further limit unnecessary bycatch in our waters.

Lastly, I would like to thank Ms. Anne Vanderhoeven for her service and leadership over the last three years.
